	<b>CO&amp;E REPORT</b> Martin Vicente, <i>Community</i> <i>Outreach Field Specialist</i>	<ul> <li>Richard Seidman, MD, MPH, L.A. Care's new Chief Medical Officer attended the meeting and reported on the following:         <ul> <li>Innovative Program (E-Management): New technology that enables primary care physicians to connect to a psychologist to assist the member better with services.</li> <li>Practice Transformation Network: A grant that allows 3,000 clinics to sign -up (not all are part of L.A. Care's network) to hire coaches that will assist them to improve services for their members. The coaches will assist with transforming practices to be more modern with technology and provide better services to their patients.</li> <li>NCQA (National Committee for Quality Assurance): The preliminary scores for L.A. Care improved from last year. L.A. Care needs to continue to work on improving member</li> </ul> </li> </ul>

experience scores as those continue to be low.
Global Member Issues
<ul> <li>Francisco Oaxaca, Senior Director of Communications and Community Relations, provided and update on the RCAC 9 motion regarding the Children's Clinics in Long Beach.</li> <li>L.A. Care's internal team had a conference call with the Children's Clinics in Long Beach about the long wait times that RCAC 9 discussed a few months ago.</li> <li>The Children's Clinic will be providing a presentation at RCAC 9 on what to expect when making appointments with their facilities and accessing the services.</li> <li>Mr. Oaxaca also shared with the committee a document "How Long Should I Wait for Appointments?" that can be found in your meeting packets for review.</li> </ul>
<ul> <li><u>Approval of Revisions to the Operating Rules for the Community Advisory Committees and Executive</u> <u>Community Advisory Committee of L.A. Care Health Plan</u></li> <li>The motion to approve revisions to the consumer advisory Operating Rules did not pass.</li> <li>RCAC members received a copy of the report describing how all RCAC, CCI and At-Large members voted.</li> </ul>
<ul> <li><u>Hilda Perez, L.A. Care's Board Member Consumer Representative on Operating Rules</u></li> <li>Mrs. Perez informed members the Operating Rules were not approved. She informed members that it was very important on how the decision are made and on how it will affect current and future members.</li> <li>Mrs. Perez informed that it was very important to make the right decision and that it is very</li> </ul>
empowering that L.A. Care takes their input in consideration. She informed that she will continue to bring forth more information about any changes to the Operating Rules for the advisory committees. Legislative updates
Lourdes Serving RCAC Vice Chair read the following Legislative highlights.
<ul> <li><u>American Health Care Act (AHCA)</u></li> <li>On June 22<sup>nd</sup>, Senate Republican leaders released a draft of their health care bill called <i>"Better Care Reconciliation Act"</i> or BCRA</li> <li><u>BCDA provides deeper suits to Medicaid than the House passed bill called the American Health Care</u></li> </ul>
<ul> <li>Lourdes Serving RCAC Vice Chair read the following Legislative highlights.</li> <li><u>American Health Care Act (AHCA)</u></li> <li>On June 22<sup>nd</sup>, Senate Republican leaders released a draft of their health care bill called <i>"Better Ca</i>"</li> </ul>

<ul> <li>Act (AHCA).</li> <li>It provides less help in the form of subsidies and tax credits for low-income and middle class families who are purchasing their health care coverage through the marketplace. It could mean higher deductibles and increased out-of-pocket costs because tax credits would be based on skimpier plans.</li> <li>Like AHCA, BRCA allows insurers to charge older people fives time more based on age.</li> <li>It removes funding for women's health providers like Planned Parenthood and makes certain essential health benefits like maternity coverage and contraceptive coverage optional.</li> <li>The Congressional Budget office (CBO) found that BCRA will result in 22 million more Americans losing coverage in 2026 than under the current ACA.</li> </ul>
<ul> <li><u>SB 562 – Single Payer Health Care Update</u></li> <li>On June 23, 2017, Assembly Speaker Anthony Rendon announced that SB 562 would not advance to a policy hearing in the Assembly. The goal of SB 562 was to create a single-payer plan, operated by the state government, which would guarantee coverage for all California residents, regardless of immigration status, with no premiums, co-payments or other out-of-pocket costs. Assembly Speaker Rendon said he supported the concept but called the bill "woefully incomplete" and said that it would stay in the Assembly Rules Committee "until further notice". As the bill did not address financing or operational structure issues, it is highly unlikely the bill will be brought back for consideration this year. However, based on the unknown future of federal health care reform, it is highly likely that discussions of single-payer will continue.</li> </ul>
<ul> <li><u>CO&amp;E Report</u></li> <li><u>Legislators Member's District List</u></li> <li>Martin Vicente informed members that it was very important to know who their government representatives were. He informed members that CO&amp;E created a sheet with the names of their Senators and Assembly Members, district they represent as well as their profile, which included address and phone numbers.</li> </ul>
<ul> <li><u>Annual Fall Conference Cancelation</u></li> <li>RCAC members were informed that the fall conference scheduled for September 22, 2017 was cancelled. A message from management was presented to RCAC members and Martin read the following:</li> <li>Today I am announcing the cancellation of our annual Advocacy Conference which was scheduled for Friday, September 22, 2017.</li> </ul>

		<ul> <li>We know many of you were looking forward to the conference however, we want to assure you that information such as 2018 work plan, our goals for the New Year and acknowledgment of accomplishments work will be addressed during our individual meetings.</li> <li>While the conference is something that we look forward to each year, we believe that it should be anchored in things like value, empowerment, education and most of all results. Results that leave you with a sense of purpose and direction. Our plan moving forward:         <ul> <li>To press pause and evaluate the current operations of the RCACs</li> <li>Look at new ways in which we can re-engage advisory members to serve their intended purpose.</li> <li>Partner with you to move our work in a new direction.</li> </ul> </li> <li>With the health care environment changing we must position ourselves to meet the challenges ahead. We ask that you see this not as a loss but for an opportunity to roll up our sleeves and do what we do best:         <ul> <li>Come together as a team</li> <li>Critically think about change</li> <li>Help us to consider new ways of approaching our work</li> </ul> </li> <li>I will be sharing info about operation "RESET" during our next meeting.
