Care's new Chief Medical Officer attended the meeting and reported on the following:         <ul> <li>Innovative Program (E-Management): New technology that enables primary care physicians to connect to a psychologist to assist the member better with services.</li> <li>Practice Transformation Network: A grant that allows 3,000 clinics to sign −up (not all are part of L.A. Care's network) to hire coaches that will assist them to improve services for their members. The coaches will assist with transforming practices to be more modern with technology and provide better services to their patients.</li> <li>NCQA (National Committee for Quality Assurance): The preliminary scores for L.A. Care improved from last year. L.A. Care needs to continue to work on improving member experience scores as those continue to be low.</li> </ul> </li> <li>Government Affairs Update</li> <li>Senate Health Reform Bill</li> <li>On June 22<sup>nd</sup>, Senate Republican leaders released a draft of their health care bill called "Better Care Reconciliation Act" or BCRA. BCRA was released as a discussion draft to allow the Senate Republicans to identify their specific "demands" of what they wanted included in the effort to undo key provisions of the Affordable Care Act (ACA).</li> </ul> |

# **Highlights of the Bill:**

- BCRA provides deeper cuts to Medicaid than the House-passed bill called the American Health Care Act (AHCA).
- It provides less help in the form of subsidies and tax credits for low-income and middle class families who are purchasing their health care coverage through the marketplace. It could mean higher deductibles and increased out-of-pocket costs because tax credits would be based on skimpier plans.
- Like AHCA, BRCA allows insurers to charge older people fives time more based on age.
- It removes funding for women's health providers like Planned Parenthood and makes certain essential health benefits like maternity coverage and contraceptive coverage optional.
- The Congressional Budget office (CBO) found that BCRA will result in 22 million more Americans losing coverage in 2026 than under the current ACA.
- Senate Republicans had hoped to vote on the bill the week of June 26<sup>th</sup>, however the bill faced resistance and they did not have the votes to pass a bill. Therefore, the vote will be delayed until after Congress returns from its July 4<sup>th</sup> recess in order for the Senate Republicans to try to re-write the bill and get a new analysis from the CBO office. This will give the Republicans more time to see if they can get the needed votes to pass the bill before bringing it back to the floor for a formal vote. As a reminder, if the BCRA does pass the Senate, it will be sent to the House for a vote as well, before it can be passed into law.

## SB 562 - Single Paver Health Care Update

- On June 23, 2017, Assembly Speaker Anthony Rendon announced that SB 562 would not advance to a policy hearing in the Assembly. The goal of SB 562 was to create a single-payer plan, operated by the state government, which would guarantee coverage for all California residents, regardless of immigration status, with no premiums, co-payments or other out-of-pocket costs.
- Assembly Speaker Rendon said he supported the concept but called the bill "woefully incomplete" and said that it would stay in the Assembly Rules Committee "until further notice". As the bill did not address financing or operational structure issues, it is highly unlikely the bill will be brought back for consideration this year. However, based on the unknown future of federal health care reform, it is highly likely that discussions of single-payer will continue.

## **State Budget Update**

• <u>Full Restoration of Adult Dental and Vision Benefits</u>
Beginning on January 1, 2018, adult Medi-Cal recipients will have access to full dental services. This

- restoration of benefits will cover gum treatments, rear root canals and partial dentures. Currently, adult Medi-Cal recipients only receive some dental services.
- No sooner than January 1, 2020, adult vision services will be fully restored for adult Medi-Cal recipients to include frames and lenses (currently, for most Medi-Cal recipients, only the eye exam is a Medi-Cal benefit). However, the state budget language states that the funding must be available for the restoration to be implemented. On a related note, AB 1092 (Cooley) passed out of the Assembly and is in the Senate. AB 1092 fully restores the adult vision benefit to include one pair of eyeglasses every two years. L.A. Care has a support position on this bill.
- All RCAC members received a copy of the Government Affairs report in their packet.

## **ECAC Ad-Hoc Committee - Meeting Effectiveness**

- The ECAC Ad-Hoc Committee Meeting Effectiveness presented their recommendation to ensure effective meeting at ECAC that included the following:
  - o **Agenda Items and Time:** All agenda items will have a time allotment. The time allotted will include time for questions and answers.
  - o **ECAC members and the public**: Both will be allowed to speak for 2 minutes. If time is limited, the Chair will notify them that time allowed to speak has been reduced to 1 minute. Both will only have the opportunity to ask one question or provide one comment.
  - Comment Cards: We will continue to use comment cards and will be numbered in ordered received. If a question/comment was not answered due to time, members and the public can write the question/comment on an Index cards and staff will follow-up.
  - o **Pilot and Training:** The recommendations will be pilot during the September ECAC meeting. An educational sheet with the meeting process will be created to distribute to ECAC and the public.

# Frank Meza, Community Outreach & Engagement

# Operating Rules for the Community Advisory Committees and Executive Community Advisory Committee of L.A. Care Health Plan

- The motion to approve the revisions to the Consumer Advisory Operating Rules did not pass.
- The majority of ECAC members voted against the motion and a list of how each ECAC member voted was provided to the RCACs for their reference.
- Staff will keep the RCAC updated on what the next steps are.

### Letter from L.A. Care CEO, John Baackes

• L.A. Care CEO, John Baackes, provided a letter to all RCAC members to inform them of his commitment to keep them informed about L.A. Care's efforts to ensure the voice of the two million Medi-Cal members is being heard in the ongoing health care debate.

- Mr. Baackes talked about the current proposals from Congress, which go beyond repeal and replace, or even repair of the Affordable Care Act (ACA). The proposals would impact all 74 million Medicaid beneficiaries across the nation, and not just those who gained Medi-Cal coverage under the ACA.
- L.A. Care, along with nine other Medicaid health plans from across the nation, recently sent a letter to the Senate's leadership urging all U.S. Senators to carefully consider the changes they are contemplating. They also gave several compassionate alternatives to the severe cuts being proposed.
- RCAC members were encourage to contact their Field Specialist if they had any additional questions.

### **2017 RCAC Fall Conference**

- The 2017 RCAC Fall Conference scheduled for Friday, September 22, 2017 was cancelled.
- Board Member, Hilda Perez shared her concerns about the conference being cancelled and felt this would lose the momentum in terms of RCAC members being able to engage with other members about the 2017-2018 Work-Plan projects focus.
