Transportation for Medical Appointments	IV.	Member Issues	 Rachel Rose Luckey provided an update regarding pain management for gender re-assignment surgery. Before the surgery, electrolysis is needed. Electrolysis is the permanent removal of hair. In order to have electrolysis, lidocaine injections have to be given. These injections are numbing medication for such procedures. Currently, when electrolysis is approved, there is no automatic approval of the lidocaine injections. Thus, Rachel has to pay out of pocket for the injections, which are very expensive. Rachel has brought forth her issue to Member Services and her issue has been forwarded to Phinney Ahn, L.A. Care's Chief of Staff, and Emmi Monsour of the Behavioral Health Department. The goal is to make policy changes to ensure members can receive automatic approval for lidocaine injections if electrolysis is required. Member Issue 2 Mirna Gonzalez shared that her daughter's eye doctor charged her to dilate her eyes. Mirna contacted Member Services but have not heard back from them in a month. Maricel Amurao, Health Navigator, provided ways members can report issues: Contact VSP's Member Services Department. Members receive their visions services through VSP. Members can also contact LA. Care's Member Services Department to bring up the issue on their behalf. If L.A. Care's Member Services Department does not get a response from VSP, it will then be forwarded to the Health Navigator. Mirna will talk to Maricel after the meeting to follow up.

		Idalia De La Torre, <i>Field Specialist Supervisor</i> , shared that members have brought up transportation issues when going to their doctor appointments. She reminded members that it is very important that members report problems so that L.A. Care can improve transportation services.

		 Desiree Gutierrez from the Behavioral Health Department presented on Autism and Autism Spectrum Disorder (ASD) benefits with L.A. Care Health Plan. Children with Autism/ASD have a developmental disability that may or may not impair functioning in one or more of the following areas: Socialization/Social Interactions with Others Verbal and Nonverbal Communication
		 Repetitive Behaviors Problem Behaviors If children show symptoms of Autism, they should be seen by a Primary Care Physician as soon as possible for treatment and referral to a Regional Center. A list of Regional Centers was provided. Members were encouraged to contact the Behavioral Health Department for more information. A one page fact sheet was passed out.
