- The July 20, 2018 meeting summary was approved as presented.

Meeting and Punctuality

ECAC and Board Meeting Update

<u>Janet Sevilla, RCAC 8 member</u>, did not attend the ECAC meeting on August 8, 2018 and reported the following:

<u>Dioselina Garcia, RCAC 8 member</u>, attended ECAC meeting September 12, 2018.

- Dioselina Garcia informed that Mr. Oaxaca, *Senior Director of Communications and Community Relations*, informed that hurricane Florence was a good wake up call to organize an emergency preparedness trainings for the CACs and L.A. Care. He informed that he will connect with the American Red Cross to see if they can provide the training.
- An ECAC member inquired about installing an automatic door at the reception area at L.A. Care's headquarters office. Mr. Oaxaca responded that this will be very costly for L.A. Care, and that a good solution will be for the receptionist to open the door for members who need assistance.
- Flyers were distributed at ECAC with information about mosquitos, particularly in the city of Long Beach. A recommendation was made not to leave standing water as it attracts mosquitos to nest.
- Members were informed that Medi-Cal covers hearing aids and its batteries.
- RCAC Chairs and Vice-Chairs that completed the terms were recognized with a certificate. Mrs. Garcia congratulated Maria Montes for serving as RCAC 8 chair for the past two years.

<u>Judith Lemaroy</u>, <u>RCAC 8 Member</u>, did not attend the Board of Governors on September 6, 2018.

- Mrs. Montes informed about the success Brilliant Corners is having with the funds provided to them by L.A. Care. She informed that a recipient was already sponsored and established in a home and that they are currently working in supporting more families with housing.
- Mrs. Montes informed that L.A. Care has continued the reviewing the Antelope Valley Clinic and its working on resolving lack of doctors in the Antelope Valley area.

CO&E Report

Elevating the Safety Net

- A power point presentation given by John Baackes at the ECAC meeting in September was given to members. Martin Vicente gave a brief description about the presentation. Mr Vicente informed members that "Elevating the Safety Net" is an initiative aim at fortifying the safety net with primary care providers in the County of Los Angeles.
- There are three initiatives that L.A. Care is working on to achieve this and they are, physician recruitment & retention, medical school loan repayment, and medical school scholarships. To accomplish this L.A. Care has committed \$31 million dollars that will be spread among these initiatives.
- Members were informed that a version of the PowerPoint will be email to them in Spanish.

Care Harbor

- Member were informed that Care Harbor is a program that is a gateway to care for the most vulnerable communities and which offer free services from, medical, dental and vision, the event will take place from the 13th to the 15th of October.

- Dominga Pardo, Robert F. Kennedy representative and RCAC advocate, informed members that the Robert F. Kennedy Center has workshops on how to empower member on advocating for themselves. Mrs. Pardo informed members that she will try to bring more information and maybe a presenter to the RCAC to educate members on advocacy. She shared it was very important to prepare yourselves when going to the doctor, this will help make the doctors aware of the health issue.
- Members were also concern on the health plans refusing prescriptions for some medications, when as a member you have the right to obtain it.
- Members would like to expose these issues at ECAC as well as the BOG to see what responses they could get.
- Dorothy Lowery, RCAC 8 member, encouraged members to file grievances with L.A. Care, she informed members that it makes a big difference when something is documented.
- Martin Vicente informed members that all the member issues documented with L.A. Care, have a trail. Some of the actions L.A. Care is taking to address some member issues is by creating initiatives like the "Elevating the Safety Net" initiative.
