Approval of Agenda & Meeting Summary

- The agenda for September 18, 2019 was approved with the following amendment: Health Care Workforce Development presentation was canceled.
- The meeting summary for July 16, 2019 was approved as presented.

Executive Community Advisory Committee (ECAC) Meeting Report

Theodora Parlanti, RCAC 4 Member was not present to provide her report from the September 9, 2019 ECAC Meeting.

Board of Governors Report

Hercilia Salvatierra, RCAC Member was unable to go to the September 5, 2019 Board Meeting. No report was provided.

Alfonso Noriega, RCAC Member provided his report from the July 25, 2019 Board Meeting:

- This was a meeting in which much gratitude was expressed to each other for a job well done.
- California's new budget includes an expansion to Medi-Cal that would cover undocumented young adults ages 19-26.
- Hilda Perez, Board Member provided a report informing the BOG that all the RCACs she has visited are working well and doing a wonderful job.

Friendly Reminder - ECAC/BOG

- Members were informed that if they cannot commit to attend an ECAC/BOG, it is better not to commit. If you do commit and cannot attend, this absence will count against the allowed absences within a fiscal year.
- Members were informed to come prepared to report back to the group with 2-3 important points gathered at ECAC/BOG. If anybody has any issues obtaining information at these meetings, they were encouraged to reach out to Mr. Rivas.

CVS minute clinics

- Members were informed that L.A. Care has contracted with CVS minute clinics. Because of this L.A. Care members can now go to these medical clinics located inside specific CVS pharmacies to receive quality medical care, and urgent care services if needed.
- Not all CVS minute clinics are contracted with L.A. Care, so members were strongly encouraged to call members services before going to one of these clinics, to verify which CVS minute clinic they can go to for services.

LGBTQ Health

- Rachael Luckey, *Vice Chair* distributed an article to all committee members and spoke about some reasons on why L.A. Care/RCAC 4 should care about the health of the LGBTQ community.
- The LGBTQ community faces health disparities linked to societal stigma, discrimination, and denial of their civil and human rights. It is important for L.A. Care/RCAC 4 to take these factors into consideration in order to eliminate these health disparities (included in the Social Determinants of Health), to ensure that the LGBTQ individuals can live long and healthy lives.
- Ms. Luckey will provide this information in Spanish to L.A. Care staff to ensure proper dissemination within the committee.

Community Outreach & Engagement (CO&E) Report

Public Charge

• Members were informed that in the early weeks of October all members will receive by mail an L.A. Care statement on public charge, fact sheets as well as resources to obtain legal counsel if needed.

- A member asked, where would a member submit a complaint against an L.A. Care employee, or against a Board Member?
- In response members were encouraged to call the Compliance Hotline at 1-800-400-4889, or you could also call Member Services at 1-888-452-2273; members were encouraged to be ready to provide dates, names and details in regards to any incident they want to report.
- If a member would like to submit a complaint against a Community Outreach & Engagement (CO&E) staff, members were encouraged to reach out to Idalia de la Torre, Field Specialist Supervisor at ext. 4020, or to Auleria Eakins, Manager, CO&E at ext. 4280.
- Another member informed the committee that she has encountered a lot of people having issues obtaining their hearing aids. Some have L.A. Care as a health plan, and other do not. She was wondering if she should submit a formal motion through RCAC 4 to address this issue.
- In response Maribel Gonzalez, CSC Member Advocate clarified that hearing aid benefits is a covered benefit. Any L.A. Care recipients having issues should call Member Services, and non-L.A. Care members should call their assigned Medi-Cal health plan.
- Another member informed the committee that in the future, if anybody would like to submit a formal motion through RCAC 4, to contact Mr. Rivas at least 5 days before the scheduled meeting to add the motion to the agenda on time to be Brown Act compliant.

2018-2019 Sponsorship

- o Members were informed that the \$5,000.00 sponsorship money has been awarded to Central City Neighborhood Partners (CCNP).
- This agency fights food insecurity by distributing food once a week, CCNP, hosts "Thursday at CCNP", and the food distribution is open to any Los Angeles City or Los Angeles County resident who is low to moderate income and is experiencing food insecurity.
- "Thursday at CCNP" happens every Thursday, from 10 a.m. − 1 p.m., at 501 S. Bixel St., Los Angeles, CA 90017. Other services provided at the event also include transportation coupons, free educational workshops (i.e., computer, English), and other resources.
