 - John Baackes, L.A. Care CEO, reported about L.A. Cares goal to increase the number of physicians that are available to L.A. Care members.
 - In addition, he mentioned L.A. Care is trying to contract with all the hospitals that can provided services to L.A. Care members and increase access to care in areas where there may be a high need.

Board Meeting Report

- Ruben Gavidia, RCAC Member attended the November 1, 2018 Board meeting and shared information about the following:
 - Mr. Gavidia stated a RCAC member asked L.A. Care for money and resources for when someone loses a family member or loved one. Mr. Gavidia mentioned Mr. Baackes will connect the member with someone that can direct the person to additional information and resources.
- Janner Gavidia, RCAC Member did not attend the December 6th Board meeting.
- Damaris Cordero, RCAC 10 Chair, provided a report from the December 12th ECAC and December 6th Board meeting.
 - The Board received a report on the L.A. Care's sponsorships for 2017-2018. Sponsorships are grants that support events and promote L.A. Care's name in the community.

- There was a presentation by Alex Gallegos, Sr. Director of Sales and Marketing and John Cota, Director of Creative and Marketing Operations, about this year's L.A. Care Covered Marketing Campaign
- There was also a presentation from Mr. Oaxaca, Sr. Director of Communications and Community Relations about the proposal restructure of the Coordinated Care Initiative Councils. There were many people who provided input to the Board on this item.
- Dr. Richard Seidman discussed current on ongoing activities L.A. Care will focus on to increase HEDIS scores that include but not limited to:
 - Breast Cancer Screening
 - Educational Materials on Controlling Blood Pressure
 - Call to member with Asthma to refill their prescription
 - Vaccine education
 - Care Management Program with Lunicera a prescription service provided to assist members that have Rheumatoid Arthritis, Multiple Sclerosis and Atopic Dermatitis.
 - Hepatitis C Management
 - Reminder calls to CalMediConnect (CMC) members to get their prescription refills.

- Martin Vicente, CO&E, presented on the outcomes of the 2018 RCAC work plan events. The presentation included the following:
 - 2018 Work plan partnership focused on improving women's health, a health priority identified by L.A. Care's Health Services Department informed by the organizations Healthcare Effectiveness Data and Information Sort (HEDIS) scores. HEDIS is a quality measurement tool used by health plans across the country.
 - L.A. Care offered funding opportunity for not-for-profit entities to help L.A. care members with:
 - Increase access to women's health services for vulnerable and low-income residents
 - Raise awareness of community services and resources focused on women's health
 - Engage multiple sectors (healthcare, economic, transportation, faith-based, etc.) to strengthen community collaboration efforts focused on women's health.
 - Services provided by the partnership with organizations included:
 - Resources reading material
 - Telephonic Outreach for diabetes

- Health Fairs
- Mental health Forums and Workshops
- With a total attendance of 22, 435
